PREPARATION OF A MANUAL FOR THE MANAGEMENT AND FINAL DISPOSAL OF CHEMICAL PRECURSORS

Support for preparing a diagnosis of precursor management in the country (including the legislative and regulatory framework, institutional mapping, and aggregated statistical

information), with a view to preparing a comprehensive manual for the management and final disposal of chemical precursors. Within the framework of this support, a study

visit to Costa Rica has been promoted and online training activities on the manual have been carried out for the country's technical staff.
