### MAINSTREAMING THE GENDER APPROACH IN THE NATIONAL DRUG OBSERVATORY

A mapping of human, financial and institutional resources has been developed, which has enabled the creation of a national research network, led by the NDO. This process is accompanied by the creation of a Scientific Committee on Drugs, which will systematically advise the observatory. Support to the Venezuelan Drug Observatory in reviewing, from a gender approach, the methodological design of a study of patients admitted to hospital emergency rooms for problematic drug use.
